



SOCIETY TERMS & CONDITIONS

Bookings

- Golf day packages illustrated are for a minimum of 12 players.
- A non refundable deposit is required by cheque or card within 3 weeks of a provisional booking. If deposit is not received within this time Farrington Park reserves the right to release the booking for the benefit of other customers (we will endeavour to call you first).
- Please choose one meal item from each course for your whole group together with any special requirements.
- Meal choices must be given no less than 7 days prior.
- Final numbers to be given 48 hours before play. This will be the amount that will be payable on the day unless numbers increase.

On the day

- The balance of any charges will be required for the final confirmed numbers (including no shows) before commencement of play. Increases can be made but cannot be guaranteed owing to other bookings.
- All food and drink consumed on the day must be purchased at Farrington Park.
- Farrington Park is unable to accept responsibility for damage to or loss of guest's property.
- The customer will be charged for any costs incurred for the making good of any damage caused to the building or material property of Farrington Park by guests of the customer.
- Please be aware of our other customers at the club. We would kindly ask that you allow faster players to play through on the golf course and keep noise down to a minimum both on the course and in the clubhouse.
- The customer will be held responsible for the behaviour and actions of their guests. Any behaviour not deemed to be appropriate by Farrington Park may result in the entire party being asked to leave the premises without refund.
- Please note that the main clubhouse is a no spikes area. We would be grateful if all clubs and trolleys were left in the trolley park outside the sports room or pro shop and not in front of the main entrance.

Cancellations

- Cancellations can be made more than 2 months before the date of play. The deposit will be held by Farrington Park to be transferred to another date.
- Cancellations of less than 2 months within the date of play will result in a loss of deposit.

Clubhouse and restaurant

We would be grateful if customers maintained a smart appearance at all times:

Smart collarless t-shirts are acceptable

Smart jeans (not holey!) are acceptable

Beach or football shorts, vests, work wear, dirty or paint splattered clothes are not acceptable

Please remove headwear at all times

Clean soft spiked golf shoes can only be worn in the Sports Room and not in the main clubhouse.

18 hole Duchy Course

Shirts: Must have a collar (No rugby, football or 'football logo style' shirts)

Trousers: Golf trousers, smart trousers or chinos are acceptable (No denim jeans or tracksuits)

Shorts: Smart knee length or plain cargo style shorts are acceptable (No beach, camouflage, denim or football/gym shorts)

Socks: Must be worn at all times

Shoes: Must be golf shoes with spikes or soft spikes

9 hole Manor Course

Shirts: Must be smart (not dirty or ripped) and worn at all times

Trousers: Must be smart (not dirty or ripped)

Shorts: No beach or football shorts

Socks: Must be worn at all times

Shoes: Must be trainers or golf shoes with spikes or soft spikes

Please do not be offended if you are asked to change for being incorrectly dressed.
